#### Virginia Master Gardener Association Bimonthly Director's Meeting February 10, 2018 Roanoke, VA

The meeting was called to order at 1005 by President Joe Kelly (Arlington/Alexandria). He introduced Donna Haley, the Recording Secretary of the Roanoke Master Gardener Association. She welcomed us to 'Star City' and gave a brief overview of their unit's 2017 statistics and current projects. They have 87 active and seven inactive members that logged in 7660 hours and 4850 contacts last year; they also have seven emeritus members. They are an active unit with a lot of different programs that include 4H gardens, horticulture therapy, and judging items at the county fair. They have a help line and a speaker's bureau too. They assist with special events at the Virginia Western Community College Arboretum, do demonstrations on rain barrels and composting and even do a rain garden demonstration/tour. The tour that they offered on Friday at the Arboretum was only attended by one person.

Joe again thanked Tonya Harper, the Roanoke VMGA unit rep and all the Roanoke master gardeners for hosting the meeting, and we began the bimonthly meeting with introductions.

**Secretary's Report:** Wanda Gerard (Suffolk) reported that the minutes for December 10, 2017 meeting had been distributed electronically and asked if there were any changes that needed to be made. There were none. Twenty Master Gardener units were represented at the meeting (35 members/spouses). The unit rep roster, a 'Thinking of You' card for Jim Kincaid and a birthday card Dave Close were sent around the room for corrections/signatures, etc.

**Treasurer's report:** Treasurer Diane Kean (Northern Neck) reported that the CD that matured in December has been split into two CDs. One is valued at \$7,279.81 and the other at \$7,279.51. One will mature at 18 months, and the other at 36 months. The report that shows all activities for our accounts is at the end of the minutes.

**President's report:** Joe stated that he really had nothing to report on except that he reminded us of our ongoing challenge to let the rest of the world know how we do what we do within our master gardener volunteer roles. He encouraged us to promote the EMG program within any group that we are involved in or working with. We should be proud of the 'Master Gardener' title because getting it and maintaining our status annually is nothing to be shy about.

<u>Vice-President's report</u>: Joan Richards (Green Spring) thanked Joe for sharing those words and added that he has never missed a VMGA meeting since he became the unit rep for his unit y-e-a-r-s ago. She then presented to Wanda the Conflict of Interest statements for all of the current VMGA board members to be filed in the secretary's notebook. She had these in December but was unable to attend that meeting due to some medical concerns.

#### **Communication Committee**

- 7. The CALS Development liaison has not been replaced.
- CALS Development and the State Master Gardener Coordinator's Office started their 2017 letter campaign in November. 111 donors participated in 2017 and gave \$8962. \$4607 in donations went to the VMGA Endowment, and \$4355 of these donations went directly to the State Master Gardener Coordinators operating fund. When compared to the 2016 drive, there was a 9% increase in participation with a 37% increase in donations.
- 9. Many news reports are saying that charitable giving will be lower this year due to the raise in the standard deduction. I believe that makes people look like they give because they want a tax write off. It makes me feel better to think that people contribute to a cause, activity, program to support the program they believe in. If you believe, like I do, that the Master Gardener Program is worth supporting. If you believe, like I do, that having a State Coordinator office and staff is important for the success of our program and losing that support would be detrimental to our program. Then, please consider giving. Any amount is accepted and appreciated and serves to guarantee that the Master Gardener program will be here long after we are gone. That said. Our goal is to raise \$30,000 in contributions to the Endowment by MG College. Anyone who commits at least \$1000 between now and MG College 2018 will receive a lovely garden journal with our awesome logo on it. A beautiful Bald Cypress pin is awaiting you once you reach the \$1000 gift level. We have donation forms, journals and pins here for anyone who will make this commitment today. # <u>VCE</u>

- Leadership Development Training will be held on March 22<sup>,</sup> 2018 in Wytheville, Virginia. Topics will be: EMG Program Updates, Marketing and Communications, Communicating with Volunteers, Cost Recovery for Local Programs, Goal Setting for your Unit / Association and a Question and Answer Open Forum.
- 2. Strategic Planning Update: Will be doing a check in with the strategic planning team in Central Virginia (location TBD) on February 21. This will be our first check in with this team in over a year. The last strategic planning session resulted in the updated Handbook, Coordinator's Manual, online module development, new website, and many other communications / promotional items for the EMG program.
- Coordinator's Manual 2017 Edition is complete. Printed and digital copies completed, and distributed 35 at the winter Virginia Cooperative Extension Annual Conference. We will be sending the remaining Coordinator's Manuals to those Units who were not present.
- 4. MG College 2018 (June 21-24); advanced training will be Tree Stewardship. Just to highlight a couple of the Keynote speakers, we will see Joe Murray (PermArboriculture: Opportunities for a New Partnership between Permaculture and Arboriculture), Alex Niemiera (Plant Gems for the Nearsighted Or You Just Need to Look More Closely), and Dr. Jeanine Davis ("Why have a Ho-Hum Garden? Grow Some Unusual Edible Plants and Fungi") and John Seiler (Within the forests of Virginia: eating, drinking, and gossip) will be presenting.
- 5. Plant Disease and Insect Video series. Look on our YouTube Channel, Virginia

Cooperative Extension Master Gardener. Video series created with Eric Day and Mary Ann Hansen, and include short, educational videos on Cedar Apple Rust, Seridium Canker, Red Thread, and many others. We have over 10 posted now, with more on the way coming this season.

- 6. School of Plant and Environmental Science Director: Dr. Mike Evans from Arkansas has accepted the position and will be starting on April 18. This is earlier than expected, and this will help move the process of forming the School along on schedule.
- Monthly Webinars Started in December 2017. January's webinar was Holly Scoggins on early spring flowering plants. There were almost 200 EMGs who joined the webinar. They are recorded and posted for later viewing. We will be having one webinar per month for the next 12 months, with a mix of technical topics and state office/program updates.

We broke for lunch a/o 11:20 and agreed to resume at 12:00. The meeting was reconvened at 12:10, and the Roanoke Master Gardeners conducted an awesome raffle before we continued with the meeting.

# <u>Announcements/For the Good of the Order:</u> "How do units publicize MG events/programs to the public?"

- 1. Joe started the discussion off by emphasizing what he'd said earlier about the importance of sharing the passion of your love for the program with anyone and everyone you meet. He stated that Devon's communication goals would greatly help our units as they continue to strive to reach more people.
- 2. Marilyn provided this input for the James City/Williamsburg Master Gardeners. Advertise in local newspapers, the Virginia Gazette, Daily Press and the digital Williamsburg/Yorktown Daily. Radio spots on the local radio station. Posters are placed in the JCC and Williamsburg Rec Centers and libraries and Farmer's Markets when we are having a MG event. Window notices are placed in local businesses (Wild Birds Unlimited for example.) Emails are sent to previous Master Gardener clients (from the pruning, the Landscape Love and Turf Love clinics.) We also advertise in the newsletters for local HOAs. Our best advertising is 'word of mouth'. Our reputation speaks for itself.
- 3. Betsy Brown (Bedford) said that their main way to advertise is to put information in the community newsletters that residents sign up to receive. They also use the local weekly paper the Smith Mountain Lake paper, Facebook, their website and at booths when at the Farmer's Market. The community newsletters are the best though.
- 4. Bill McCaleb (Halifax) said that their FM radio station's 6AM breakfast club show runs several times a day, so advertising on that program is worthwhile since they see immediate response in their programs, their mg classes, etc. They also advertise in two newspapers that come out three times a week. They have a website, and a Facebook page. They use the local Baptist and other church associations to get info into church bulletins. He asked how many units used social media for reaching out and almost everyone present raised their hand. They also worked carefully with the Soil & Water District to provide a rain barrel program where the participants could purchase a rain barrel for only \$12.00
- 5. Lynn Jones (Rockbridge) said that they use a biweekly newspaper. They have banners printed up for different events and the city of Rockbridge hangs them on

Main Street. Everyone was jealous of this!

- 6. Diane Kean (Northern Neck) said their unit recently purchased a Constant Contact membership.
- 7. Joan Richards (Green Spring) said they use the community website (Next Door) and the Fairfax County Park Association website.
- 8. Fern Campbell (Piedmont MGs) said that in addition to those already mentioned, they have generic Piedmont MG business cards that can be handed out.
- 9. Amy Weber (Chesapeake) reported that they have a problem with the newspapers. They will do articles on regular or special events which promote their cause, but they are unable to get anything into the calendar of events. Their local reporter Mary Reid Barrow is awesome, but most everyone agrees that reporters want a photograph to accompany a story.
- 10. Joe added that for the northern Virginia Master Gardeners, there is overlap of newspaper coverage, and the ongoing confusion of the Arlington and Alexandria city lines along with Fairfax County.
- 11. Fern added that the Virginia Gardener magazine is a great way to promote an event.
- 12. As always any of our events can be sent to a VMGA communications committee member for posting on the VMGA website and to John for the biweekly mg updates that are sent out.
- 13. Mary Ann Kincaid (Virginia Beach) via email aid that their Facebook and pubic websites are popular. Bookmarks and flyers are available to members to distribute to their garden clubs, neighbors and at any other events they are involved in. It is important to build a relationship with a reporter for your newspaper who will write about your big events. She added that they need to come up with a 'hook' for each new thing they want covered. Their Communication's committee has a chairperson and they reach out to the various groups of the unit for advertising needs. For library events, there are flyers on the counters. They now have a Seed Exchange at the Main Library where every patron can have five packets of seeds per month.
- 14. Bonnie Bernard (Gloucester) via email said that they have a weekly column in the Gloucester/Mathews Gazette on gardening tips posted by Susan Camp, one of their Master Gardeners. Upcoming events are also advertised with that column. Last year we stated advertising once a month on the local radio station (99.9) with a morning spot about current activities occurring in the upcoming month. For larger events we also post flyers around town and put separate articles from our weekly column with pictures. We feel that the support we received from our community with all of our endeavors is also a good way disseminate information to the public.
- 15. George Graine (Fairfax) via email reported that the Fairfax Master Gardeners have a public website fairfaxgardening.org. Anyone can click on the various "headers" and find varied information in addition to the ability to ask questions. The site also has a log-in header for their mgs.
- 16. Joe stated that his unit has an area on their website with a replace this plant with a better alternative plant. It contains photos, descriptions, etc. for the person visiting the website to viewers.
- 17. Cynthia Falconer (Loudon) shared that they have handouts in their local libraries.
- 18. Betsy Brown said that the Bedford library holds seminars and workshops and they pay for the materials. There are six branches, and they are always well attended. Wanda commented that we were not at lucky in Suffolk. The library wants us to hold things, and then forgets to advertise it so the attendance is poor even though we do our own advertising.
- 19. Joan Richards said that they have exhibits in all 21 libraries. The exhibits can be

rotated around to the different or stay in place if it is not needed elsewhere. They usually stay in place for one month.

- 20. Fern Campbell said that they have community information racks (plastic rack to hold papers) that contain timely information about upcoming and seasonal gardening information. They are at the libraries, Lowes, and the Southern States stores. They have volunteers that restock these twice a week.
- 21. Cynthia Falconer also stated that they hand out a packet at the school's science fairs that contains a seed with information for the kids to take home and plant it.
- 22. Bill McCaleb emphasized the importance of working with locally owned newspapers – things just get done better that way and he should know, he's been doing MG stuff for 26+years. It takes time to build good working relationship with the folks at the different organizations, including newspapers. We must remember that as a MG, we are our best advertisers. They have had successful rain barrel programs, and are now beginning to do rain g

#### Old Business: none

#### New Business:

- 1. Joe announced that it is time to form the Audit Committee for 2018. The annual audit is done at the end of our fiscal year so the books can be closed out before MG College in June.
- 2. Georgianna Hall volunteered to serve on the audit committee. Joe said we should inquire of our members if anyone has served in their real life jobs as auditors... they must be a MG.
- 3. Diane mentioned that we should establish a protocol for the audit committee members.
- 4. Bill McCaleb asked that we determine whether or not we are having a financial review or audit. A financial review is done internally versus an audit being done by external sources. Since ours are done internally, we should check to see if a change needs done to our bylaws.
- 5. Jody mentioned that Pat Brownell of Appomattox was a great source last year for the audit committee to get the final numbers of our inventory items in conjunction with the actual audit.

Other information:

- 1. Amy Weber mentioned that Kandy Keith has recently gone through two knee surgeries and is now experiencing a pinched nerve. Wanda said she had put a get well card in the mail for her just this week.
- 2. Erica Jones said that the New River Valley mgs are taking a bus trip to the Philadelphia Flower Show on March 8-10 and that have four vacant seats. Interested folks can contact her for additional information. They will also visit Longwood gardens.
- 3. Cheryl Sebera (Prince George) said to look for the information about their spring gardening symposium in the biweekly updates that John sends out.
- 4. Diane said that their garden symposium being held on March 24<sup>th</sup> can host 350 people. Registration opened on February 1 and they have over 200 already. Register quick if you want to attend.
- 5. Marilyn mentioned that if anyone wanted to support the local Ronald McDonald house, which it is a stone's throw away from the church today and there are some

interesting and great purchases there that can help that worthwhile organization.

- 6. Wanda shared that Susan Garrett, the unit rep for the Northern Shenandoah mgs has just resigned. She is moving to California later this year.
- 7. Fern asked how we share information with our units that we take back from these meetings. Most do so via their monthly meetings, or email, or in a unit newsletter. Joe attends his units board meetings and shares the info there. Jody suggests we share it via email since we sometimes have a lot of info to pass along. We can always get additional information from vmga.net
- 8. Wanda mentioned she was working with the webmaster on updating a lot of older files so that the minutes for a year are filed under one entry, versus separate entries. She encouraged members to contact her if something was missing or incorrect.

#### <u>Closing</u>

Wanda announced that Gloucester will be hosting the April 14 meeting and said that meeting information would be shared as soon as possible.
